for PETROLEUM, OIL & LUBRICANTS (POLs) AND HAZARDOUS SUBSTANCES (HS) Spills

TO PETROLEUM, OIL & LUBRICANTS (POLS) AND HAZARDOUS SUBSTANCES (HS) SPIIIS

For: uncontrolled, dangerous, or unknown substance spills, spill in drains, and <u>all off-base spills</u> IMMEDIATELY CALL: 911 or from off-base / cell 098-911-1911 (Fire Dept. Spill Response)

Provide: a. Your name, phone number and location of spill

- b. Type of spill POL or chemical, and Time spill occurred
- c. Critical Event; accident, injuries, mechanical failure persons injured/missing
- d. Status of site: Fire? Local Police on-scene? Reporters taking photos? Etc...

Take Action: Can the spill be stopped, contained, and cleaned-up without danger to health & safety?



Secure Area. Stop the Spill and Evacuate the area. Keep people and traffic away from area; move vehicles & equipment as needed.

• Use shower/eyewash station if required.

Stop and Control Spill. Wear PPE. Apply spill supplies; Drain Covers, Booms, and Socks to prevent spills from entering the environment. Then absorbents; pads and dry sweep. Neutralize corrosive spills, if trained.



After-Action - provide/update spill event information to your Camp Environmental Coordinator.



MOVE TO A SAFE DISTANCE AND CONTACT EMERGENCY SERVICES:

Dial 911 or 098-911-1911 from a cell

Report the following information:

- Location of Spill
- Quantity and type of material spilled.
- Your name and phone number

Do the following only if you have adequate training to do so without risk to your safety:

- Stop the material from spilling (shut off valves, turn drum upright, trigger emergency shut-off.).
- Contain the spill with available spill response equipment (absorbent socks, booms, sand bags, etc.).
- Divert the spill to an area where it will cause less harm using dikes or berms.
- Stand by to aid emergency response personnel when they arrive.

After-Action - provide/update spill event information to the Camp Environmental Coordinator.

ECC ACTION: Notify Unit OOD. Complete and submit EMSP 07.1.2 ECC Spill Report Form to Environmental Affairs Branch personnel immediately during normal duty hours or at the start of the next normal duty day for after-hours events. Form can be obtained using QR Code →
