

PREAMBLE: This is a MILITARY DOCUMENT prepared pursuant to Title 10 United States Code, Section 1044b, and executed by a person authorized to receive legal assistance from the military services. Federal law exempts this power of attorney from any requirement of form, substance, formality, or recording that is prescribed for powers of attorney by the laws of a state, the District of Columbia, or a territory, commonwealth, or possession of the United States. Federal law specifies that this power of attorney shall be given the same legal effect as a power of attorney prepared and executed in accordance with the laws of the jurisdiction where it is presented. **All adjutants and assistant adjutants; commanding, executive, and administrative officers; legal officers; officers in the grade of O-4 and above; and Marine Corps E-4 and above while holding a legal assistance billet are authorized to act as federal notaries under title 10 of the United States Code section 1044a.**
