1. Purpose. Per the reference, the III Marine Expeditionary Force (MEF) and Marine Corps Installations Pacific (MCIPAC) Commanding Generals are charged with establishing the holiday liberty schedule each calendar year.

2. Cancellation. CG III MEF/MCIPAC-MCBBBul 1050 SSEC dtd 11 Oct 2018.

3. Action. III MEF and MCIPAC will observe the following special liberty hours for the prescribed events:

4. Coordinating Instructions

a. All personnel are aware that operational requirements may surface which will supersede the authorized liberty.

- b. Commanders will emphasize the importance of using common sense and the responsible use of alcohol during the holiday periods. Situational awareness must be highlighted during safety briefs.
- c. Civil service employees will observe the Federal holiday. Liberal leave is encouraged for civil service employees for the remainder of the special liberty period. Any leave taken will be charged as annual leave or leave without pay, as appropriate.
- d. Super Bowl special liberty period is an authorized 72 hour liberty for III MEF and MCIPAC Marines and Sailors stationed west of the International Date Line. Liberal leave is authorized for civil service employees.

5. Applicability. This Bulletin is applicable to all III MEF and MCIPAC major subordinate command and major subordinate element personnel.
