Subj: AUTHORIZED RESALE LOT FOR PRIVATELY OWNED VEHICLES ABOARD CAMP
FOSTER

Ref: (a) MCIPACO 5560.1

1. Situation. As the largest populated Marine Corps camp on Okinawa, Camp Foster has steadily become a prime location for Department of Defense Identification (DOD ID) cardholders and their dependents desiring to sell Privately Owned Vehicles (POV). Unfortunately, vehicles placed "for sale" are appearing in locations throughout the Camp, occupying office and retail parking spaces. As a result, individuals attempting to conduct business in these establishments are forced to seek parking in other locations.

2. Cancellation. CampO 11240.1C

3. Mission. To establish policy and procedures governing the placement of POVs to be sold by authorized DOD ID cardholders and their dependents in a centralized location in order to provide ease of shopping for used vehicles and to free up parking spaces outside office and retail areas.

4. Execution

a. Commander's Intent and Concept of Operations

(1) Commander's Intent. To establish a centralized location for the reselling of POVs aboard Camp Foster by authorized personnel.

(2) Concept of Operation. The privilege of owning and operating a POV on Okinawa inherently comes with personal, professional, and financial responsibilities. This privilege, according to the reference, extends to the resale of a vehicle or motorcycle when a service member or dependent no longer desires to own the POV or is in receipt of orders off the island.

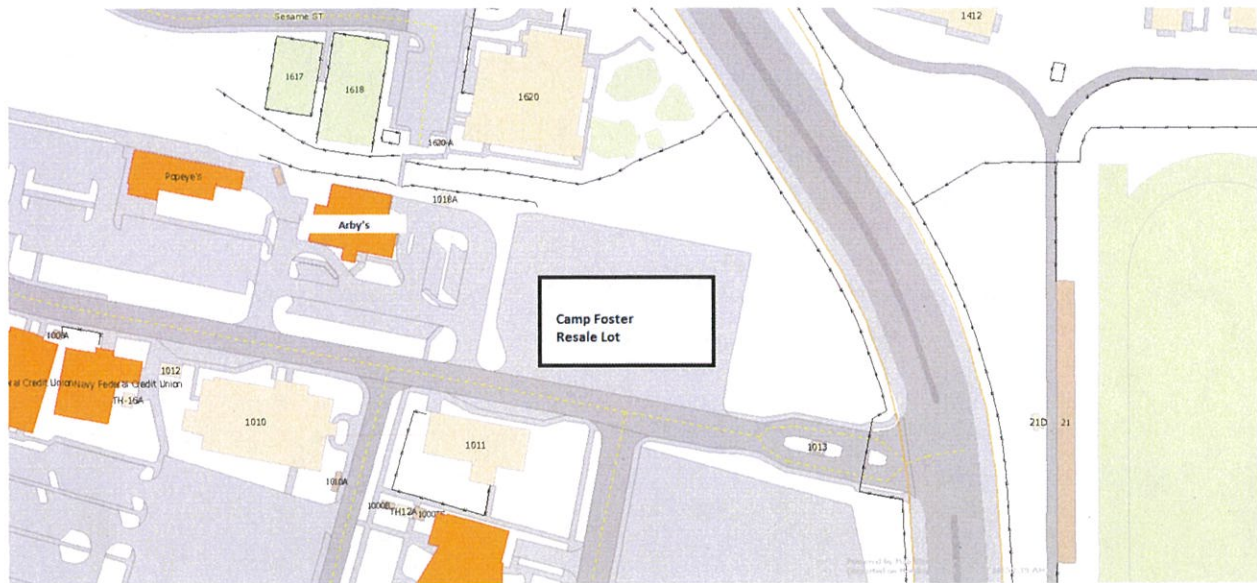


FIGURE 1. CAMP FOSTER RESALE LOT AUTHORIZED LOCATION

(a) The Camp Foster Resale Lot will be the only authorized location for vehicles to be parked and physically advertised "for sale." This location is closest to Camp Foster Gate 2, adjacent to Arby's see Figure 1).

(b) All POVs for sale at the Camp Foster Resale Lot must have valid auto insurance, Japanese Compulsory Insurance, road tax, and current license plates. In addition, POVs must be registered with Camp Services and display a Resale Lot Pass on its dashboard.

(c) All POVs will be free from leaks and operational at all times. If a leak or any other problems arise with the vehicle, the owner will have 24 hours to fix the problem or the vehicle will be towed at the owner's expense. Camp Foster is not responsible for stolen vehicles, any damages, or theft to the vehicles that are placed on the Resale Lot by the owner.

(d) The Resale Lot Pass can be obtained at Typhoon Motors Building 5971 on Camp Foster from 0800 to 2000, Monday to Friday and 0900 to 1800 on holidays.

(e) The owner must inform Camp Services of any changes to their contact information. This includes any period where the owner will be off Okinawa for more than one day.

(f) Upon registration with Camp Services, the vehicle's owner has 30 days to sell the vehicle. If a vehicle is not sold during this timeframe, the owner must reregister the vehicle with Camp Services. Failure to reregister a vehicle may result in a Minor

Offense Report (MOR) issued by the Military Police and the vehicle towed at the owner's expense.

(g) If the vehicle's owner fails to sell the vehicle and departs the island, effectively "abandoning" the vehicle at the Camp Foster Resale Lot, the vehicle will be treated as an "abandoned vehicle" and will be turned over to the Military Police to be disposed, in accordance with the reference.

(h) Once the vehicle is sold or if the owner no longer desires to sell it, the car must be deregistered with Camp Services by calling DSN 315-645-7317 or email MCB Butlcr Camp Services@usmc.mil.

b. Tasks

(1) Camp Director

(a) Ensure that vehicles are not being advertised as "for sale" in high traffic or parking areas such as the Exchange, WestPac Lodge/Inn, Marine Corps Community Services Center and Commissary or any other location aboard the Camp.

(b) Contact possible violators and inform them of the proper procedures for selling a vehicle aboard Camp Foster. If the owner cannot be contacted or is unwilling to comply with this order within 1 day, Military Police will be notified and reported as Camp order violation and may be considered as an abandoned vehicle.

(c) Periodically survey the Camp Foster Resale Lot to ensure vehicles have a Resale Lot Pass and have not been abandoned.

(2) Military Police District Central

(a) Issue MORs to a registered vehicle's owner to determine if the vehicle is being advertised "for sale" at any location other than the Camp Foster Resale Lot. Ensure vehicles that are identified as abandoned are properly disposed in accordance with the reference.

5. Administration and Logistics

a. Registration. Vehicles parked in the Camp Foster Resale Lot must be registered with Camp Services. Owners of unregistered vehicles parked in the Camp Foster Resale Lot may receive a MOR issued by the Military Police and could be subject to towing at the owner's expense.

b. Resale Lot Passes. All vehicles and motorcycles that are properly registered and insured are eligible for a Resale Lot Pass, in addition to those vehicles and motorcycles that are being sold through

a valid power of attorney. It is the responsibility of the owner to ensure that the Resale Lot Pass is properly displayed on the dashboard of their vehicle or taped to their motorcycle seat in a protective document cover.

6. Command and Signal

a. Command. This Order is applicable to all personnel physically advertising their vehicle for sale aboard Camp Foster, Marine Corps Installations Pacific-Marine Corps Base Camp Butler.

b. Signal. This Order is effective the date signed.
