1. Purpose. To provide Occupational Safety and Health training in accordance with references (a) through (d).
2. Action. All training classes are limited to a minimum of (5) students. Participation is highly encouraged for all personnel regardless of rank or billet. Quotas are assigned on a first-come, first-served basis unless otherwise posted. The deadline for registration is three working days prior to the scheduled course date. If less than (5) students register by the deadline, the course will be cancelled and enrolled personnel will be notified via email.
3. Supervisor Safety training is reserved for those in supervisory positions grades E-4 and above and civilian equivalent.
4. The Ground Safety for Marines (GSFM) course is for unit level Ground Safety Officers/Managers. Students attending the GSFM course must be E-6 or above, be appointed in writing as the Ground Safety Officer/Manager (GSO/GSM) by the commanding officer, and have at least one year remaining on station to fulfill GSO/GSM duties.
5. Enrollment for all courses unless noted otherwise per enclosure (1), is through the ESAMS Training Calendar at [https://esams.cniv.navy.mil/ESAMS\\_Gen\\_2/Login](https://esams.cniv.navy.mil/ESAMS_Gen_2/Login). If you do not have an ESAMS account you can enroll through ESAMS "Global Training" under the "SOH Classroom". Enrollment for both ESAMS and non-ESAMS account holders are at the above link.
