Subj: CONTROL OF BANNER AND SIGN DISPLAYS ON CAMP FOSTER/LESTER

- 1. <u>Purpose</u>. To establish policy for the display of banners and signs aboard Camps Foster and Lester. This policy also establishes approved locations for routine display of banners and signs.
- 2. <u>Background</u>. In accordance with reference (a), paragraphs 3-211a/b, non-Federal entities (NFE) may request permission to hang banners and signs in designated locations on Camps Foster and Lester. If the NFE resides on a Marine Corps Installations Pacific facility or area, there will be a presumption that the criteria of JER 3-211a/b are met, subject to the restrictions enumerated below.
- 3. <u>Discussion</u>. The use of banners is effective as a supplemental means of advertising events and programs which improve the quality of life for the Marines, Sailors, and families living and working aboard the camp. Banners improperly displayed on fences may detract from the camp's appearance. Improperly displayed banners can also become a safety or security concern by distracting and hindering the view of personnel passing by in high traffic areas or by blocking the view of camp security personnel. Signs mounted on trailers are also regulated by this policy.
- 4. Policy. The display of banners and signs is authorized only in approved locations. Perimeter fences and immediate vicinity

of any gate will not be approved. Base safety is authorized an exception upon approval and may post safety banners in a safe manner close to gates so that departing traffic can view the safety message.

- a. Enclosure (1) provides a list of approved banner locations.
- b. Enclosure (2) is the request used for the display of banners and signs. Sign location approval is done on case by case basis.
- c. The following guidelines are provided to ensure the display of banners aboard the camp is fare and consistent with this policy:
- (1) Only one event advertised at a time for a maximum of 30 days.
- (2) All banners must be removed by owners within 8 hours of announcement of TCCOR-3. Any banner not removed will be taken down by camp staff. Failure to remove banners in designated time period will result in suspension of banner privileges.
- (3) Requests to display banners on MCCS sports field fences require an approved endorsement from MCCS before submission to the camp for approval.
- (4) Banners advertising approved fundraisers may be displayed but shall not advertise for, make referrals to, or encourage the use of any commercial business.
- (5) Banners that are freehand spray-painted will not be authorized.
- d. The camp services office will identify violations of this policy and take appropriate actions to have unauthorized banners and signs removed. The camp will also notify tenants when banners or signs require repairs and adjustments to ensure a neat appearance is maintained.
- e. Requestors are required to employ media other than banners and signs as their primary means of advertisements.

- f. All requests should be submitted to camp services 14 days prior to requested display date. Enclosure (2) is also posted on the Camp's web page at https://wwl.mcbbutler.usmc.mil/under the services link. It is recommended that requestors get approval of wording for their advertisements prior to purchasing banners.
- 5. This policy letter is effective immediately when signed.




Approved Banner Location # 5
